In accordance with Section 139(1)(e) of the Environmental Protection Act, R.S.O. 1990, c. E. 19 (Environmental Protection Act), I hereby give notice that, under s. 20.13 of Part II.1 of the Act, I have revoked Approval No. 6884-AGVMAN issued on February 3, 2017 for establishment of stormwater management works consisting of an oil/grit separator and swale for the collection, transmission, treatment and disposal of non-contact stormwater run-off from the above mentioned Site.

The reasons for the revocation of the Approval are as follows:

- 1. The waste Environmental Compliance Approval (ECA) #1171-9L8L2R for this site has been revoked, and no waste materials can be stored on the site; therefore, the previously-approved sewage works are not required.
- 2. The previously-approved sewage works were never constructed and do not exist.

In accordance with Section 139 of the *Environmental Protection Act*, you may by written notice served upon me and the Ontario Land Tribunal within 15 days after receipt of this notice, require a hearing by the Tribunal. Section 142 of the *Environmental Protection Act* provides that the notice requiring the hearing ("the Notice") shall state:

a. The grounds on which you intend to rely at the hearing considering your appeal.

The Notice should also include:

- 1. The name of the appellant;
- 2. The address of the appellant;
- 3. The environmental compliance approval number;
- 4. The date of the environmental compliance approval;
- 5. The name of the Director, and;
- 6. The municipality or municipalities within which the project is to be engaged in.

And the Notice should be signed and dated by the appellant.


