1. Mobilization/Demobilization - Written notice shall be provided to the Ministry of Energy and Mines, (MEM) as follows: not less than four (4) weeks prior to commencing the early exploration activities authorized by this Permit which, for greater certainty, shall include the mobilization of personnel and equipment to the site required for carrying out those activities; after a period of temporary suspension of activities of greater than four (4) weeks, not less than one (1) week prior to recommencing the early exploration activities authorized by this permit; not less than two (2) weeks prior to the anticipated final demobilization of personnel and equipment required for carrying out the early exploration activities authorized by this Permit; and delivered by email to Tbay-mdlb@ontario.ca
2. Archeological Checklist - Prior to undertaking any exploratory drilling authorized by this Permit on or within 50 metres of eskers or other glacial ridges, and/or within 300 metres of the Attawapiskat River, the Muketei River (aka Little Attawapiskat River) or McFaulds Lake, the permit holder shall provide to MEM (by email to Tbay-mdlb@ontario.ca): a completed copy of the attached Criteria for Evaluating Archaeological Potential; and a copy of any required archaeological assessment(s) as reported to and reviewed by the Ministry of Citizenship and Multiculturalism
3. Water Quality Sampling - Within 14 days prior to undertaking any exploratory drilling authorized by this Permit, the permit holder shall complete the following tests of water sources utilized in connection with that drilling activity: general chemistry; and total and dissolved solids. Results of any such tests shall be provided to MEM (by email to Tbay-mdlb@ontario.ca) within 14 days of the permit holder receiving the test results from a licensed testing laboratory.
4. Site Inspections - For each site where exploratory drilling is undertaken pursuant to this permit, within 14 days after such exploratory drilling is completed and the drill rig is removed from the site, the permit holder shall provide to MEM (by email to Tbay-mdlb@ontario.ca) written confirmation that the

permit holder has complied with Schedule 1 to O. 5. Limiting Noise & Activities under Multiple Permits The permit holder (and, where appropriate, their contractors) shall utilize sound limiting and muffling methods such as enclosures and/or silencers for diamond drill rigs while conducting any exploration drilling authorized under this Permit for the purposes of obtaining drill core. 6. 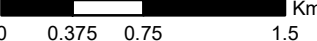
